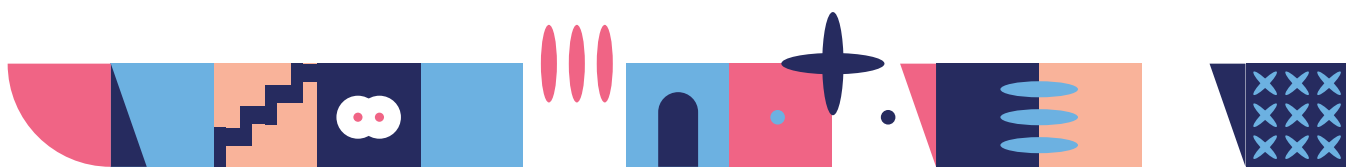
# From Positive Youth Development to Positive Youth Justice

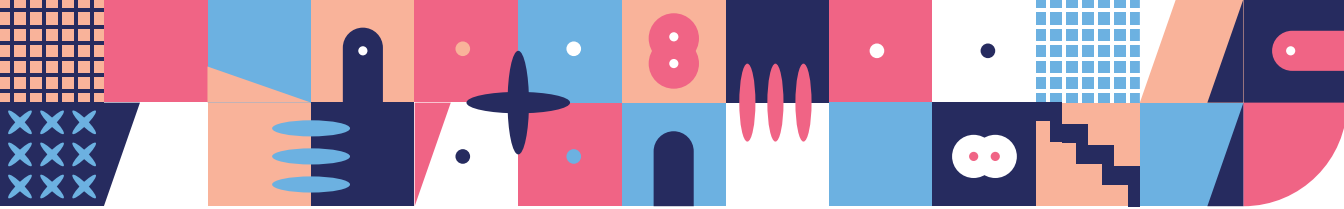

Across the globe, societies are reconsidering how best to support young people—through families, schools, and communities, especially for those facing adversity or being involved in the justice system. In Serbia, the youth have recently encountered serious challenges, including mass shootings in schools and community, as well as open crises in education, higher education, and the broader political sense. Nevertheless, comprehensive support for children and youth at the whole-school and community levels remains insufficient. At the same time, youth justice practices rarely rely on deficits and punitive responses, often overlooking young people's strengths, potential, and capacity for growth and positive change.

The aim of this conference is to create a collaborative space for researchers, practitioners, and policy-makers to come together and explore how positive youth development approaches can contribute to the brighter future for youth. Through discussions on supportive relationships, mental health, restorative justice, equitable education, resilience, etc., the conference will highlight how positive youth development and youth justice can work in synergy to foster well-being and justice for all young people.

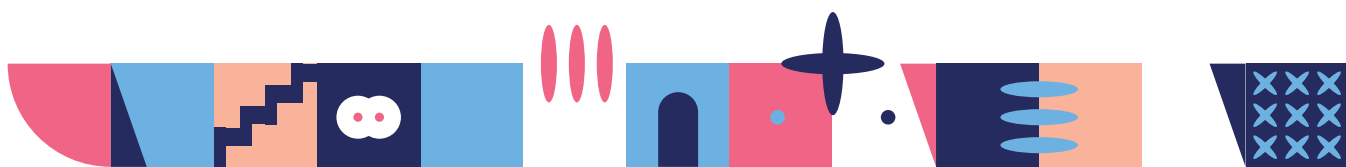
Empirical, theoretical, and methodological submissions from various disciplines related to positive youth development and youth justice are welcome.

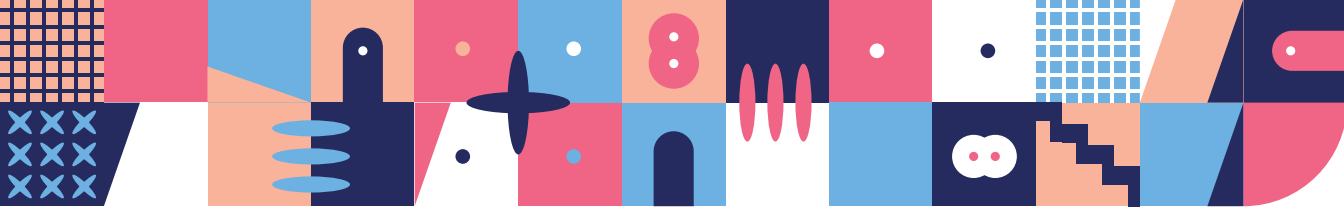

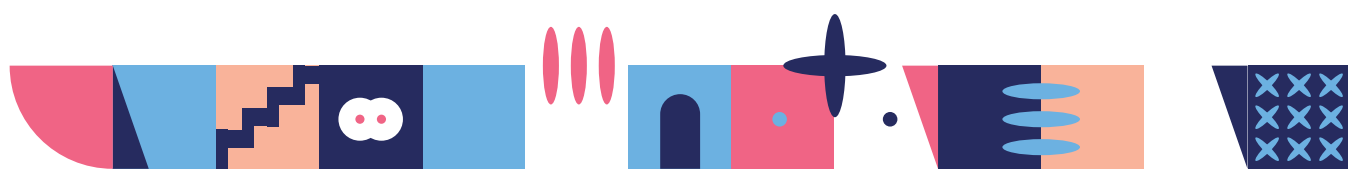


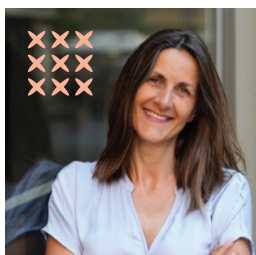
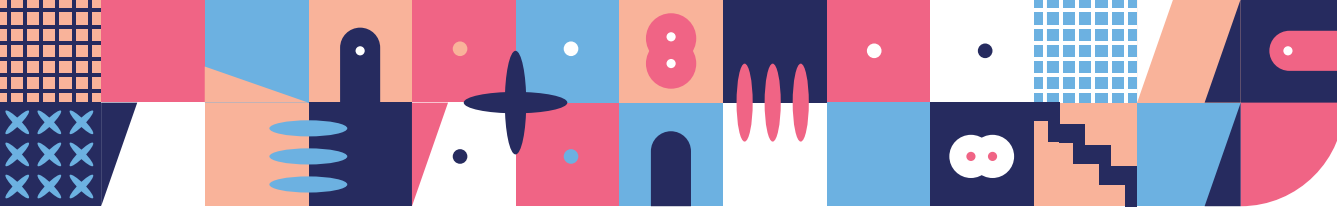
**Miranda Novak** has a master's degree in psychology and a PhD in Prevention Science. Her research interests are rooted in the interdisciplinary field of prevention science and mental health promotion, with a special focus on youth mental health and positive development, specifically, socio-emotional learning, and internalized problems prevention in children and youth. She is an associate professor at the Department of Behavioral Disorders at the Faculty of Education and Rehabilitation Sciences at the University of Zagreb.

From October 2023 she is a Head of Doctoral study program Prevention Science: Prevention of Mental and Behavioral Disorders and Mental Health Promotion. She is an active member and one of the founders of Laboratory for Prevention Research (PrevLab) that gathers a group of scientists researching development and application of effective models for the transfer of prevention science into practice. PrevLab has received two important international awards: 1) 2018 - Sloboda Medal Award of European Society for Prevention Research and 2) 2022 - The American Society for Prevention Research International Collaborative Prevention Research Award.

During 2019, she received a Fulbright scholar program scholarship that was awarded for her project "Adolescent mental health and wellbeing: Investing in healthy emotional functioning" at the Department of Clinical Psychology, University of Oregon. In her career so far, she has been an associate on 18 scientific research projects. She is currently leading a project »Testing the 5c framework of positive youth development: traditional and digital mobile assessment P.R.O.T.E.C.T.« funded by installation fund of Croatian Science Foundation.

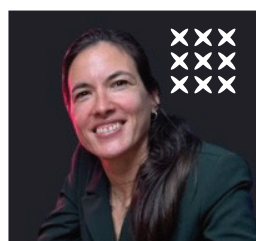

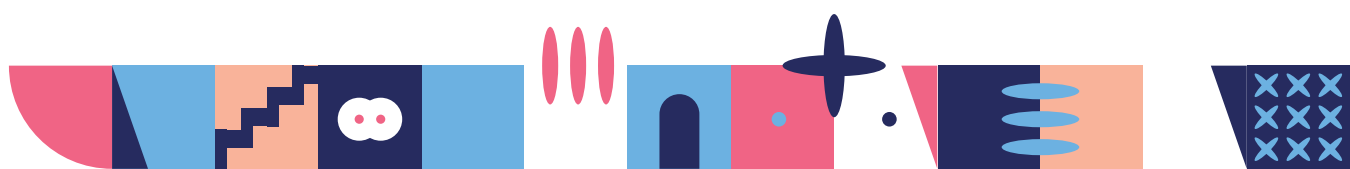


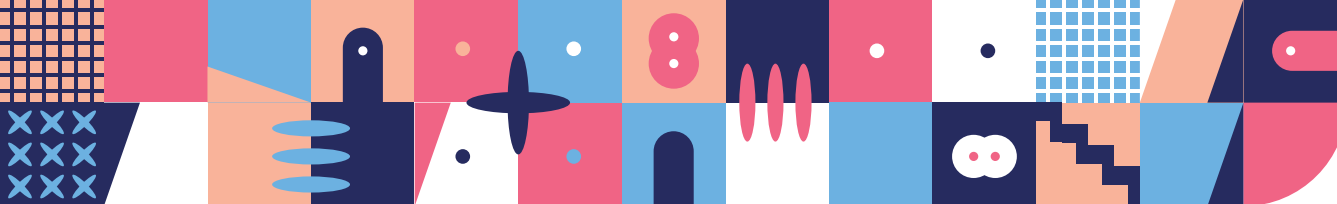
**Ksenija Krstić** is an Associate Professor of Developmental and Educational Psychology at the University of Belgrade, Faculty of Philosophy. With over two decades of academic experience, she has taught and supervised students at undergraduate, master's, and doctoral levels. Her research focuses on socio-emotional and adolescent development, particularly in the context of social vulnerability and cultural diversity. She applies both quantitative and qualitative methodologies to study how individual development is shaped by family, school, and community influences. Her work spans multiple international projects addressing issues such as early childhood development, parenting practices, school dropout prevention, playful learning, and youth well-being. She has served as principal investigator and national coordinator in several large-scale, mixed-methods studies. A unifying theme in her research is its commitment to producing context-sensitive, socially relevant knowledge that informs both policy and practice.

Prof. Krstić heads the Laboratory for Developmental Psychology at the University of Belgrade, where she mentors student researchers and facilitates applied research. She is also an associate editor of Psychological Research and an active member of several academic networks, including the European Association for Developmental Psychology, EARLI, and ISCAR. She is actively engaged in academic communities, contributing to conference programming and publishing extensively in peer-reviewed journals. She also mentors students in research and is committed to supporting the next generation of psychologists. Known for her interdisciplinary, collaborative, and context-sensitive approach, she contributes to academic development not only through research but also through the organization of conferences, seminars, and workshops. Her scholarly work is widely published in peer-reviewed journals, and she regularly engages in dissemination efforts targeting both academic and practitioner audiences.



**Dr Jelena Pavlović** is Associate Professor of Organizational Development at Change at Department of Psychology, Faculty of Philosophy, Belgrade. She has authored two books with Routledge: Coaching Psychology: Constructivist Approaches (2021) and Partnering with AI in Coaching and Human Skills Development: Constructivist Guidebook for Innovation. She is passionate about the intersection of technology, learning and development.

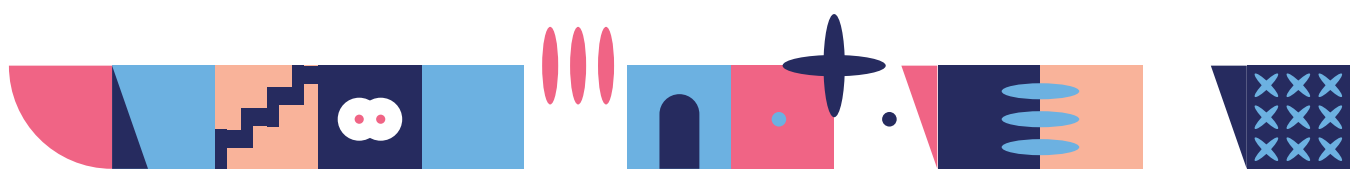


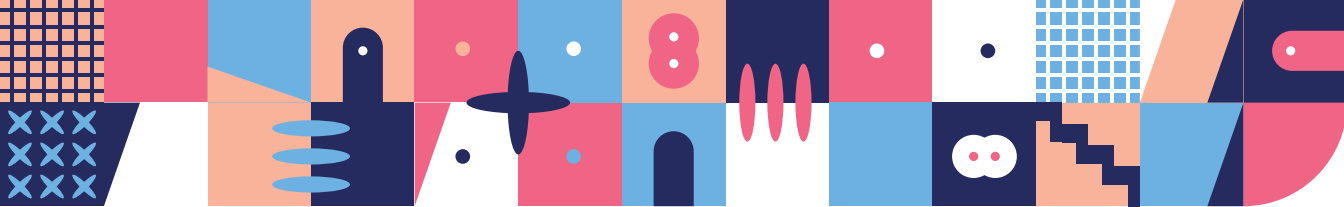
**Prof. dr Sanja Ćopić** is an Associate Professor at the University of Belgrade – Faculty of Special Education and Rehabilitation (Serbia). She was a researcher in the Institute for Criminological and Sociological Research (1995 to 2000, and 2002-2022), and the Institute of Social Sciences (2000-2002). Dr Ćopić is one of the founders of the Victimology Society of Serbia (VDS) and serves as the Chair of its Executive Board. She is a member of the European Forum for Restorative Justice and the Criminology Section of the Serbian Association for Criminal Law Theory and Practice, where she currently serves as a member of the Presidency.

She has participated at 50 national, regional and international research projects; mainly action, comparative and experimental research as well as at policy-oriented projects. Her research has mainly focused on violence against women, domestic violence, human trafficking, sexual violence, women in prison, victim services, legal protection of crime victims, restorative justice, alternative sanctions, gender equality, juvenile delinquency, and crime recording. As an author or a co-author, she published 10 books and more than 150 papers in national and international academic journals, edited books and conference proceedings' books. She participated at more than 70 scientific conferences and meetings in Serbia and abroad. Since 2019 she has been serving as Editor-in-Chief of the academic journal on victimization, human rights, and gender, *Temida*.



**Myunghoon Roh** is an Assistant Professor in the Department of Criminal Justice and Criminology at Salve Regina University. Roh does research in juvenile delinquency, criminology theory testing, cross-national criminal justice system, and human microbiome research. His research interests are how individual internal and external characteristics impact crime and deviant behavior.

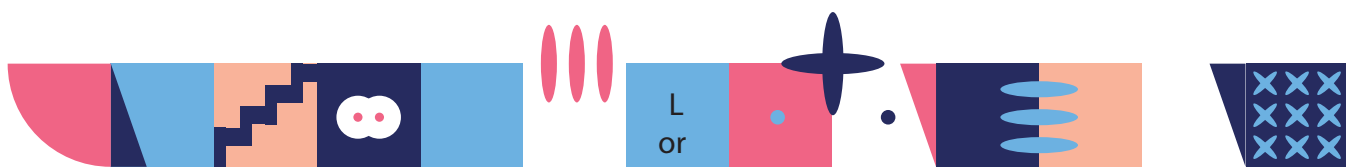

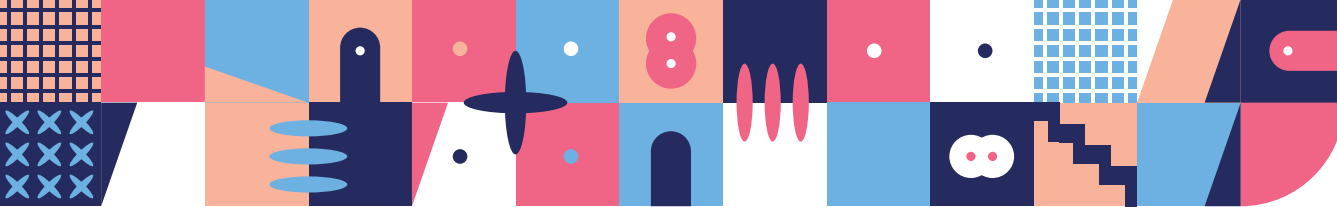

### The Needs and Position of Young People with Experience of Growing Up in Alternative Care in Serbia: Perspectives of Youth and Practitioners
